MANUFACTURING OF FORAN EQUINE FOR-REPRO STALLION AND FOR-RECOVERY

RAW PRODUCT

The raw active product in these products is Ubiquinol CoQ10, developed by and sourced exclusively from leading science innovation company, Kaneka. Their method of Ubiquinol CoQ10 mass production and their regular, random quality testing, ensures consistent purity and quality.

Patent protection means that the only source of this pure and unadulterated Ubiquinol CoQ10 for horses is via Foran Equine products.



GOODS IN

Raw Ubiquinol CoQ10 is received into the Foran manufacturing plant and the packaging immediately assessed for damage during transit that may risk product contamination or degradation. Product is rejected if this is suspected. A unique identity code is issued that follows each batch through the manufacturing process, ensuring traceability throughout.

RAW PRODUCT TESTING

Before being released into the manufacturing process, raw material from each batch is analysed by experienced personnel for any evidence of product degradation or contamination.

THE PRODUCT LINE

GMP compliant production lines process the raw Ubiquinol CoQ10 into FOR-REPRO Stallion and FOR-RECOVERY. Everything about this process is directed to making sure that the end product is consistent.

END PRODUCT

Bulk end product testing occurs before packaging, as another check for quality. A 10% w/v pH test makes sure that the product powder is suitable for use.

PACKAGING

FOR-REPRO Stallion and FOR-RECOVERY are packaged in sealed, daily-use sachets. This is to ensure consistent dosing, as well as freshness both during transit and storage by the customer, so the horse receives the same quality product, each and every day.

CLEAN SPORT GUARANTEE

Foran has a strong commitment to Clean Sport and is proud to ensure absolute compliance with global anti-doping regulations, as defined by leading regulatory bodies, such as FEI and all major racing authorities around the world. We pride ourselves on the close relationships which we have with these regulatory bodies.

This is achieved via batch level traceability from raw product to end product, coupled with access to in-house laboratory testing technology, such as liquid chromatography and mass spectrometry, as well as approved, external independent testing facilities such as Le Laboratoire des Courses Hippiques (LCH) in France.

Customers can be assured that any product carrying the Foran S.A.F.E logo (Strict Anti-doping Formulation Ensured) is safe for use in competition horses.
